Dear Members,

National Committee wish to advise Members that the following changes have been made to the Show Rules with regards to the age groups for showing Horses:-

SHOW RULES

ELIGIBILITY FOR SHOWING: RULE II:

J. AGES:

For showing purposes the following age groups are suggested:

JUNIORS:

Weanling

Yearling

Two year old (actual age)

Three year old (actual age)

SENIORS:

4 - 6 years old (actual age)

7 - 9 years old (actual age)

VETERANS:

10 years (actual age) and over

Therefore Performance Classes should be:

Yearlings: Trot Poles only

Junior Hunter: 2 - 3 years (actual age)

No Show Jumping etc until 4 years actual age

The updated Show Rules will be posted on the website in their entirety.

Reminders: It is timely to remind Members of the following:-

Members are reminded that if they are buying a Horse and they want to check if it is MHAA® registered to ask the seller to show you a copy of BOTH sides of the Registration Certificate; this way it can be checked if the Horse is registered with MHAA® and whose name the Horse is registered in.

Members are also reminded if they send their Mare to be served by a Stallion and are told that the Stallion is registered MHAA®, ask to see BOTH sides of the Stallion's MHAA® Registration Certificate and make sure the Stallion owner provides you with a Service Certificate to record the mating.

If Members are considering sending their Horse/s for training and the person offering to do the Training says they are an MHAA® Member, or if Members are considering having someone else Show their Horse/s at MHAA® Shows; to ensure the person is an MHAA® Member, ask to see their current Membership Card.

We have had several instances lately where Members have contacted us with regards to the Purchase or Sale of a Horse and while we always try to assist Members wherever and whenever we can, we are unable to adjudicate between any arrangement made between a buyer and a seller and in most cases the old adage "buyer or seller beware" comes into play!

Stallion Breeding Reports:

As Members are aware, **Stallion Breeding Reports (Stallion Returns)** are due to be submitted by 1 August, however they can be submitted at any time and we recommend that Members lodge them as soon as they have finished serving Mares. For Members convenience attached to this E-News is a Stallion Breeding Report.

Acknowledgement of receipt of your Stallion Return will be sent, however, if you do not receive an acknowledgement within 21 days of submitting your Return, email admin@mhaa.com.au to make sure it has been received.

Regarding your **Stallion Breeding Reports (Stallion Returns)**, always remember to include all outside Mares, as well as every Mare served, even if they are not registered MHAA® and **remember to keep a copy for your records**.

Also remember that if your Mare has been served by another Member's Stallion, or you purchased a Mare in Foal, make sure that you get a Service Certificate from the Stallion owner to cover the mating.

If you purchased a Stallion halfway through the breeding year, you should submit a return from the date the Stallion arrived on your property and the previous owner should submit a return for the first part of the breeding year, until it left their property.

Livestock & Business Centre Postal Address:
