**REMINDERS - Stallion Breeding Reports (Stallion Returns): Mare Nominations: Membership Renewals**

As advised in our last E-News, although **Stallion Breeding Reports (Stallion Returns)** are usually due to be submitted by 1 August, this year due to the fact that we have been held up re-locating our Registry Office, National Committee are allowing Members extra time to submit their **Stallion Breeding Reports (Stallion Returns) and these must now be received by 31 August, 2022.**

This also applies to **Mare Nomination Forms**, these will also be **accepted until 31 August, 2022.**

Both **Stallion Breeding Reports (Stallion Returns)** and **Mare Nomination Forms** (if Nomination Fee being paid via EFT or Credit Card) will be accepted via email, so if any Member has not already submitted them via post, they can be emailed to [admin@mhaa.com.au](mailto:admin@mhaa.com.au). We also suggest that if Members are sending in Membership Renewals, Registrations, Upgrades or Transfers and need the paperwork processed to enter a Show, please put a note with your paperwork to let the Office know.

As we are preparing to commence Shows in several States, this is an ideal time to catch up on paperwork and make sure your Membership is renewed and all your Horse Registrations are up to date, as if your Horse is due for upgrade, it cannot be shown until the upgrade has been done.
